POLICY PRIORITIES DEVELOPMENT PROCESS

- Each year, AFC's Policy and Advocacy (P&A) team initiates its [policy priorities development process](#) to determine its policy agenda for the state legislative session.
- During the summer and fall of 2023, AFC staff conducted **ten (10) listening sessions** designed to engage community stakeholders in conversations about policies impacting people living with or vulnerable to HIV as well as people experiencing homelessness or housing instability. **These listening sessions included people living with HIV, people impacted by housing instability, health care and social service providers, advocates, case managers and others.**
- These priorities also operationalize AFC's intentional and responsive anti-racism work and the principle that "racism is a public health crisis" while also fulfilling the goals and priorities of the Getting to Zero Illinois (GTZ-IL) plan to end the HIV epidemic by 2030.

2024 MID-LEGISLATIVE SESSION OVERVIEW



- **The 2024 Spring session of the 103rd General Assembly gavelled in on January 16, 2024.**
- **Impact of Primary Elections (March 19th)**
 - Two Incumbents Lost (Rep. Mary Flowers & Sen. Natalie Toro)
- **This year's session will be backloaded including most days after the March 19, 2024 primary elections. The General Assembly is set to adjourn on May 24, 2024.**
- **Some of the pressing issues during this year's session:**
 - Fiscal Year 2025 State Budget
 - Ongoing Migrant Issue
 - Continued Discussion of HBIA/HBIS programs

HB5667/SB3809: STRENGTHENING AND PROTECTING ILLINOIS' HIV FUNDING INFRASTRUCTURE (SPIHFI 2.0)

This legislation includes \$4.5 million in investments to the state's HIV funding infrastructure in the state's FY2025 budget:

- HIV Lump Sum: \$2M (currently funded at \$25.56M)
- Rapid Start for HIV Treatment Pilot: \$2.5M (New Line Item)

This legislation also protects funding for the following:

- GTZ-IL: Currently funded at \$5.5M
- AAHARF: Currently funded at \$10M*
- PrEP4Illinois Program: \$2M (New FY24 Line Item)
- STIs: \$500K (New FY24 Line Item)

HB5417: CONNECTION TO HIV TESTING AND LINKAGE TO CARE (HIV TLC) ACT

This legislation enacts the following reforms:

- At-Home HIV Testing Kits: Mandates insurers and Medicaid provide coverage for home test kits for sexually transmitted infections (STIs), including HIV, without cost-sharing.
- Rapid Start Pilots: Creates eight Rapid Start for HIV Treatment pilot sites that will initiate antiretroviral therapy within 7 days of initial diagnosis or within 7 days of referral to HIV medical care.
- HIV Education in County Jails: Ensures that all county jails provide HIV/AIDS education to people who are incarcerated and visitors, as well as link them to HIV testing as mandated by Illinois' County Jail Act.

HB4472/SB3108: PRESCRIPTION DRUG AFFORDABILITY BOARD (PDAB)

This bill would establish a Prescription Drug Affordability Board (PDAB), an independent, nonpartisan body with the authority to evaluate high-cost prescription drugs and set upper payment limits on what Illinoisans will pay.

- Affects the entire supply chain (manufacturers, wholesalers, and Prescription Benefit Managers (PBMs), insurers and pharmacies)

Public Opinion:

- 28% of Illinoisans either have not filled prescriptions or rationed their medication due to cost.
- 54% of Illinoisans are worried about affording their prescription medication.
- 86% of Illinoisans are supportive of establishing a PDAB.

AFC is working in partnership with Citizen Action Illinois and the Protect Our Care Coalition on this legislation.

HB2: OVERDOSE PREVENTION SITES PILOT

**HARM
REDUCTION
SAVES LIVES**

OPS have been shown to save lives, reduce the spread of infectious diseases, such as HIV and Hepatitis C, and link those with substance use disorders to behavioral and physical health care.

Specifically, HB2 would:

- Create one Overdose Prevention Site pilot
- Connect folks to community support or other existing medical care, treatment, recovery programs and harm reduction services
- Establish minimum principles and features for OPS, informed by the harm reduction and medical communities
- Require programs to hire peers/people with lived experience along with medical staff.

HEALTHY ILLINOIS FOR ALL

AFC and the Healthy Illinois Campaign supports the following:

- Full Funding of the Health Benefits for Immigrant Adults (42-64) and Health Benefits for Immigrant Seniors (65 and older) in the state's FY25 budget
- Reopen enrollment in HBIA/HBIS programs without co-pays.
 - HBIA and HBIS program participants are in the middle of transition from fee for service to the Medicaid Managed Care Organizations (MCOs).

During his 2024 State of the State Address, Governor Pritzker announced his proposed budget for next fiscal year (FY25) which included \$629M in funding for Health Benefits for Immigrant Adults and Seniors programs. The funding does not include program re-opening.

Short-Term Limited-Duration Plans vs. Traditional Health Insurance

Must accept every applicant

Charges same premiums regardless of gender or health status

Covers pre-existing conditions

Covers essential benefits like prescription drugs, hospitalization, mental health, and maternal health

There is a limit to what patients may owe for treatment

PROTECT OUR CARE IL

HB5395 includes several healthcare insurance reforms including:

- **Ban Junk Plans:** Bans short-term limited duration “junk” plans that often deny coverage to people with chronic conditions like HIV and result in higher premiums.
- **Ban PAs for Mental Health:** Bans prior authorizations for in-patient hospital-setting mental health treatment for adults and children.
- **Ban Ghost Networks:** Requires insurance companies to conduct 90-day internal audits to ensure their provider directories reflect the reality of healthcare that’s available to consumers in that network.
- **Rate Review for Large Group Plans:** Requires insurance companies to obtain prior approval from the Department of Insurance before large group plans hike rates on consumers.
- **Premium Realignment:** Requires premiums to align with the actual cost of providing healthcare insurance.

FUNDING TO PREVENT & END HOMELESSNESS

Housing is healthcare, especially to people living with or vulnerable to HIV.

Advocates will be asking for \$85 million in new funding in the state's Fiscal Year 2025 budget:

- Homelessness prevention
- Emergency/Transitional Housing
- Homeless youth programs
- Supportive housing, and other priorities

AFC and the Center for Housing and Health are proud to partner with community partners Housing Action Illinois, Chicago Coalition for the Homeless, Illinois Shelter Alliance, and the Supportive Housing Providers Association (SHPA) in this advocacy.

SB2158/HB3703: STOP THE REVOLVING DOOR FROM RE-ENTRY TO HOMELESSNESS TO PRISON



Current Illinois registry and housing banishment laws systematically displace, exclude and reincarcerate people—disproportionately Black men—with past convictions.

Specifically, this legislation enacts the following reforms:

- Reduce housing banishment zones from 500 to 250 feet and once people find safe and stable housing, grandfather them in.
- Repeal the extra “weekly” registration. Register people based on “duty to register,” not their housing status.
- Make “failure to register” a misdemeanor (from a felony).

AFC is working in partnership with the Chicago 400 on this legislation.

BILL SPONSORS: Senator Kimberly Lightford (D-Hillside) and Representative Camille Lilly (D-Oak Park)

HB5051: BAN ON PRIOR AUTHORIZATIONS IN HEALTH INSURANCE PLANS

Prior authorization is a requirement by health insurance plans for patients to obtain approval of a health care service or medication before the care is provided.

American Academy of Family Physicians is among those who contend that prior authorizations “can worsen health disparities and create barriers to care for medically underserved patients, patients of color, LGBTQ+ patients, patients in rural areas, and those at risk for poor health outcomes.”

Specifically, HB5051 would ban prior authorizations in health insurance plans for prescriptions prescribed to a patient for six or more consecutive months for:

- Insulin
- HIV PrEP/PEP & treatment
- Viral Hepatitis (HCV) treatment
- Hormone therapy medications including, but not limited to estrogen, progesterone, and testosterone
