

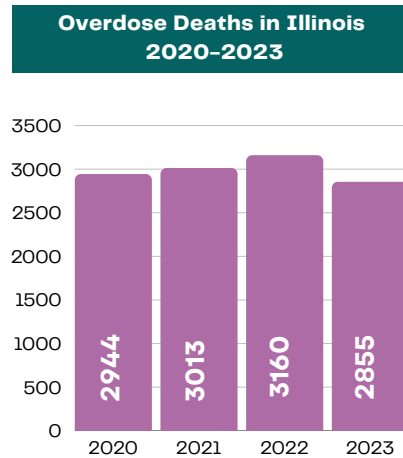

Overdose Crisis in Illinois

- Nearly 3,000 Illinoisans died from an accidental overdose in 2023.
- An increased supply of potent fentanyl and other contaminants in street-bought drugs across the state will continue to exacerbate the crisis.
- There is a government need to support and scale harm reduction strategies to adequately respond to the crisis.



Support HB2929

- Trained health workers and people with lived experiences will provide **life-saving interventions and support.**
- The pilot will connect people to community support services like **drug treatment, medical care, and criminal legal aid.**
- Authorizes DHS, along with an advisory committee, to **promulgate rules for implementation and pilot location.**
- Outlines the **requirements** for a pilot.
- Requires IDHS to collect research and data and provides **a report within 12 months of operations.**

What is an Overdose Prevention Site (OPS)?

An Overdose Prevention Site is a hygienic **healthcare facility** for people to use *preobtained* substances under the supervision of *trained staff* designed to provide *medical, mental health, and social support interventions.*

Saves Lives.

- Facilitates the connection to drug treatment, life changing supports and services (housing, job training, etc.).
- Reduces the spread of infectious diseases, such as HIV and Viral Hepatitis.

1,200+ prevented overdose deaths

Since NYC OPS was established in 2023

75% of participants were provided with wellness and stabilization services

First Year Accomplishments for NYC OPS

Saves Money.

- An OPS reduces costs by preventing hospitalizations, EMS calls, and treatments for HIV, Hepatitis C (HCV), and other illnesses.
- No funding impact for State GRF Funds.

Taxpayer Costs for Emergency Response Calls and Overdose Fatalities

PER INDIVIDUAL INCIDENT **\$30K-40K**

ANNUAL COST **\$100M**

Keeps Our Communities Safe.

- An OPS provides a supervised space which has safety and social benefits.
- Sites do not increase crime and instead have reduced robbery and property crime.
- Provides a safe place to dispose of drug equipment.
- Creates a safer space for women who use drugs who otherwise are at risk for violence.

435k units of hazard waste diverted from public spaces
